## Terms and Conditions

1. All graphics and lettering must be prepaid. If you desire to have the graphics and/ or lettering installed on the Quovis before it is shipped to the Driver, a check with a copy of this contract must be received by Vexel Automotion, P.O. Box 389, Centreville, MD 21617 before work is started.
2. The Business/ Advertiser maintains the option of having graphics and lettering created and installed on the Quovis by a local graphics shop in your area.
3. The contract term is for 60 months at \$500 per month payable to the Quovis driver. Most Drivers make a personal visit to collect this fee, unless other arrangements are made. The Driver is responsible to keep the Quovis in good condition and pay the Bank financing charges. It is important that the monthly Quovis Mobile Advertising Fee is paid on time to keep the advertising on target. The business owner has the option of controlling payments by making the payments for the Quovis and insurance directly to the Quovis finance institution.
4. Most Drivers use the Quovis as personal transportation and will be on the road 8 - 9am and 4 -5pm during commuting hours and during lunch hour Monday through Friday. To have the Quovis on the road more often and on different routes, the business and Driver should create a schedule and compensation plan that is agreeable to both parties; and additional compensation for the Driver above the standard \$500 monthly advertising fee would be reasonable.
5. The business may negotiate for a 30 month term. However, the business would be obligated to pay \$1,700 for Quovis surface reconditioning to remove the lettering and graphics.
6. Contract termination penalty is \$1,000 for Quovis surface reconditioning and graphics removal. The Contract is subject to termination if the monthly advertising fee is not paid.
7. Please review and proofread pre-production graphic plans, spelling and phone numbers carefully; we are not responsible for errors after proof is signed by you.
8. Changes to graphics after installation require Quovis surface preparation fees.
9. The Quovis Driver is a wheelchair user, who is an independent advertising service provider. The Quovis Driver is totally focused on providing an advertising service for only you. The Quovis Driver is not an employee or an agent for Vexel Automotion. Federal and State laws require the Driver to title, register and insure the Quovis. It is the Driver's responsibility to ensure that the business owner is satisfied with the program.
10. Payment is accepted by check or money order.
